TRAVEL & HEALTH DOCUMENTS

A Canadian citizen must be in possession of a passport valid for a minimum of 6 months from the conclusion of their journey. Tour participants must also ensure that they comply with all visa and health requirements of countries they intend to visit. Any inoculations required must be recorded on a valid Inoculation Certificate and in your possession for inspection by Customs/Immigration if requested.

RESERVATIONS & DEPOSIT

Early reservations are recommended as all services are on a request basis, both for air and land requirements. A guaranteed minimum deposit of \$1000 per person is required at the time of booking to confirm your request for any departure. Full and final payment is required no later than 90 days prior to first service being provided.

CREDIT CARD PAYMENTS

VISA, MasterCard and American Express are accepted as payment for most services. Cardholder signature authorizing payment and amount must be submitted to K Walsh & Associates prior to acceptance of payment and the consequent release of documents.

REFUNDS, CHANGES & CANCELLATIONS

Up to 60 days prior \$1000 penalty

59 – 45 days prior \$1500 penalty

44 – 30 days prior 50% penalty plus any unrecoverable deposits paid to airlines or suppliers

30 days prior to departure 100% non-refundable

Changes to itinerary are subject to a \$100 fee per change. Additional services are considered to be a booking and are exempt from these charges. No refunds will be made for any unused portion of the tour including hotels, sightseeing, cruises, transfers, meals, international or domestic flights with or without notice unless cancelled or missed by the supplier.

TOUR INSURANCE

To protect yourself against cancellation charges we highly recommend that you purchase adequate Cancellation, Trip Interruption, Health or Comprehensive Inclusive Insurance from your Travel Agent. Cancellation Insurance must be purchased at the time of initial deposit. If you have coverage through your Credit Card Company, it is important to confirm whether or not they cover Cancellation penalties.

TOUR DOCUMENTS

Documentation will be sent once full payment and credit card authorization has been received at K. Walsh & Associates. The documents will contain airline tickets, the itinerary and destination information.

ACCOMMODATION

Accommodation is as stated in the itinerary. All hotel taxes, service charges and government taxes are included in the tour price. Accommodation included is based on 2 persons sharing a room or double room. Single room supplements apply to all persons requesting a room for single occupancy.
